This manual is to walk you through the steps in raising a claim online for Auction Proceeds. Customs is vested with the right to sell by public auction the goods and vehicles which are lying unclaimed in the port /storage premises upon expiry of the permitted storage period. The permitted storage period from the day of discharge at the port shall be as follows.

FCL normal cargo Three calendar months FCL refrigerated cargo One month. LCL cargo Six months.

After the periods stated above, the containers shall be un-stuffed and the goods removed for sale by Public Auctions.

*Proceeds resulting from the auction can be claimed by the rightful party by raising an Online Claim request.*
